- 1. The above un audited financial results for the quarter/nine months ended on 31st December,2022 have been reviewed by the Statutory Auditors, recommended by the Audit Committee and approved by the Board of Directors at their meeting held on 14th February, 2023.
- 2. The Auditors have given their Limited Review Report on the unaudited financial results for the quarter ended on December31, 2022 which was also reviewed by Audit Committee and the Board.
- 3. This statement has been prepared in accordance with the Companies (Indian Accounting Standards) Rules 2015(IND AS) prescribed under section 133 of the Companies Act 2013 and other recognized accounting practices and policies to the extent applicable.
- 4. In view of migration from SME platform to Main Board of NSE, the Company has adopted Indian Accounting Standard ("Ind AS") beginning from April 1, 2022 and for that purpose comparative figures of previous year and quarter is restated.
- 5. The financial results have been prepared in accordance with the Ind AS prescribed under Companies (Indian Accounting Standards) Rules, 2015. Beginning April 01, 2022, the company has for the first time adopted Ind AS with the transition date of April 01, 2021. There is no material impact on financial statements on account of transition to Ind AS.
- 6. The Company is primarily engaged in Retail Business, which constitute single business segment in terms of Ind AS 108 on Segment Reporting. Accordingly, there are no other business segments to be reported under Ind AS 108.
- 6. The Company had migrated from NSE SME platform to Main board on 01st Dec, 2022. In view of the compliance on half yearly on SME platform, figures for the three months quarter ended 31st December, 2021 are not provided.
- 7. The Company does not have any subsidiary, associates or joint venture as on 30thSeptember, 2022; therefore, it has prepared only standalone results as consolidation requirement is not applicable to the Company.
- 8. The Figures for the quarter ended 31stDecember, 2022 are the balancing figure between the un-audited figures of the nine months ended 31stDecember 2022 and un-audited figures for the half year ended 30th September, 2022 respectively.
- 9. Previous Year/Period figures are regrouped and rearranged, whenever found necessary.
